MOTION: By Mary Warren to remove 6370 Gunnel Road (parcel # 79-003-025-300-0400) from the garbage assessment roll and refund Lonnie Kester \$130.00 for the 2013 assessment as he has already paid it, and also refund him \$160.00 for 4 years fire assessment on a vacant piece of land in Section 15. Garbage Assessment on parcel 79-003-025-300-0400 and the Fire Assessment on vacant property in Section 15 will be removed from 2014 forward.

MOTION: By Mary Warren to authorize the supervisor to have the Tuscola County Road Commission order 1000 yards of limestone for Barkley Road from Birch Run Road to Arbela Road and also order gravel for the township wide gravel roads.

The supervisor passed out a 2014-2015 proposed draft budget which brought about considerable discussion.

MOTION: By Mary Warren to approve the Hardship Exemption Resolution for the Board of Review.

MOTION: By Mary Warren to contract with Wilkinson Corp. for 2014 calcium chloride (\$8,463.98 – 3 applications –one of the applications is carried over from 2013). We save 10% if we prepay entire cost.
