Supervisor White gave the fire board report. There was 1 structure fire, 1 other fire, 5 Power line standbys, 2 motor vehicle/pedestrian accidents, 2 misc. call, 2 false alarm and 19 E.M.S responses. In the next year or two we are going to have to replace turn out gear such as Scott Airpacks, tanks, etc. which will be costly. There is a possibility we could lease the turn out gear on a rent to buy option if the board chooses to go that route. They looked at a five year plan for fire budget. The new firefighter is done with training and on duty now.

Deputy LaFlure gave the police report. There were 3 tickets issued, 31 property inspections, 13 vehicles investigated, 13 persons investigated, and 2 papers served and 2 assists to other departments. He introduced the new deputy that will take his place after March 20.

Tim Anderson gave a blight report. He has had a few responses to letters sent on Barkley and Arbela Roads.

Supervisor White gave a road update. He said the intersections on gravel roads are very bad and may get worse before the road commission is able to grade the roads.

Supervisor white read the 2019/2020 Budget Resolution.
