December 9, 2019

The meeting was called to order by Supervisor Joe White at 6:00 p.m.

Supervisor White gave the fire board report. Delivery of the new fire truck will be the first week of January. All the equipment they would like to buy comes to \$104,680.00. Millington is looking for grants. Received one grant for \$7,000.00 from Vassar ladies group. The bread truck needs replacing as it is 35 years old and they cannot recondition it. There are five new firemen in training and one more just applied. Of the five, three are Amish and are lining up rides as they don't drive.

Deputy Glumm gave the police report. There were 8 car/deer accidents, one accident, 3 property damage, 1 larceny, 2 liquor inspections, 3 medical assist, 1 assault, and 1 assist other agency.

Supervisor White said there was one ongoing blight problem.

Supervisor White said the road commission hopes to grade some of the gravel roads as soon as it freezes. Our first choice of roads to ask for bids for 2020 are Swaffer Road, Belsay to Vassar; Tuscola Road Lewis to Willard Road and Baker Drive in the Oak Grove Subdivision. Lewis Road Millington to Sergeant Road is the oldest mile but is still in pretty good shape. He's going to see if the road commission will fill in the cracks on Barnes Road Lewis to Bray Road to try and save the road.
