Fire report. They had a meeting January 4, 2021 and elected officers. Duane Weber is chairman and Jackie Sabgash is the secretary. They sold the 1989 pumper truck for \$2,501.00. There are five people attending training in Caro and two doing medical training. It will be two years before we have to come up with balance of new fire truck.

Supervisor Hunt read the police report that was written by Deputy Coleman. For the month of December 26 complaints were handled. There is a current recall for our 2017 Explorer to replace or look at the ball joint used to attach the real toe link. The Sheriff's Office garage will be setting up an appointment to look at this issue. There were 9 non-criminal investigations, 6 assists, 1 crash investigation, 18 traffic stops and 88 property inspections.
