**FIRE BOARD REPORT:**

Joe said they had 1 structure fire, 1 power line standbys, 0 mutual aid, 1 motor vehicle accident, 1 motor vehicle accident requiring the jaws of life, 2 misc. calls, 1 false alarm, and 26 E.M.S. responses in February. Runs by location were: Arbela, 20 Millington Township, 9; Vassar Township, 0; Village of Millington, 4 and mutual aid, 0.

**BUILDING INSPECTOR'S REPORT:**

Tim Anderson reported there were 1 building permits, 1 electrical permits, 2 plumbing permit and 2 mechanical permits issued in February. The estimated valuation was \$40,000.00.

**WORK PROJECTS REPORT:**

Bill said everything has been going smooth.

**POLICE REPORT:**

Deputy Rogner said we had 1 property crime, 2 assault, 6 general non-criminal assistance, 0 traffic complaints, 0 accidents and 5 other complaints. Complaints handled by the township's two officers was 14, non-Arbela sheriff's patrol was 15 and state police 3.

They put 2,592 miles on the car and used 152 gallons of gas in February.

Joe opened the audit bids from four companies. The price ranged from \$2,800.00 to \$4,400.00. We will make a decision at our April meeting to give the board time to look over the proposals.
